

**SOONHARI HOLIDAY SWEEPSTAKES 2025
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER FOR A CHANCE TO WIN.
A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**THE SWEEPSTAKES IS INTENDED FOR AGE 21+ VIEWING IN THE FIFTY (50) UNITED STATES AND
DISTRICT OF COLUMBIA ONLY, AND WILL BE GOVERNED BY UNITED STATES LAW.**

VOID WHERE PROHIBITED.

1. SWEEPSTAKES PERIOD: The SOONHARI Holiday Sweepstakes 2025 ("Sweepstakes") sponsored by Lotte Beverage America Corp. ("Sponsor") begins at 8:00 AM Pacific Time ("PT") on December 1, 2025, and ends at 8:00 AM on December 13, 2025 (the "Sweepstakes Period"). Eligible entries will be placed into specific "Entry Pools" based on the date received; see Section 5 below for details.

2. ELIGIBILITY: The Sweepstakes is open only to legal residents of the 50 United States and the District of Columbia (the "Eligibility Area") who are age 21 years or older. Employees, officers, and directors of Sponsor, alcohol beverage vendors, licensed alcohol beverage distributors and retailers, or any of the respective parent companies, affiliates, or subsidiaries of the foregoing, or any company or individual involved with the design, production, execution or distribution of the Sweepstakes ("Barred Entrants"), as well as members of Barred Entrants' immediate families (parents, step-parents, children, step-children, siblings, step-siblings and spouse) and households (people who share the same residence at least three [3] months out of the year) are not eligible to participate in the Sweepstakes. Void outside the Eligibility Area and where prohibited or restricted by law. Sponsor's determinations of eligibility are final and may be made at any time.

3. 1. Visit <https://soonhariusa.com/12days> during the Sweepstakes Period, locate the entry form, follow the form's instructions to provide the required entry information, and submit the entry form so it is received no later than 8:00 AM PT on December 13, 2025, -OR-
2. Click the "Learn More" (or similar) action button on one of Sponsor's social media posts advertising the Sweepstakes, follow the form's instructions to provide the required entry information, and submit the entry form so it is received no later than 8:00 AM PT on December 13, 2025.

There is a limit of one (1) entry per person/email address, per day of the Sweepstakes, regardless of method of entry. For the purposes of the Sweepstakes, each day ends at 11:59:59 PM PT and the next day (if any) begins at 12:00:00 AM PT (except that the final "day" of the sweepstakes will begin at 12:00:00 AM PT on December 12, 2025, and end at 8:00 AM PT on December 13, 2025). For the avoidance of doubt, this means that an eligible entrant may earn up to a maximum of twelve (12) eligible entries, if they were to submit an eligible entry on each day of the Sweepstakes. Entries will be disqualified if they are late, incomplete and/or in excess of the stated entry limit. Sponsor's computer will be the official time clock for the Sweepstakes. You further agree that by providing your mobile phone number as part of your entry information, you are consenting to Sponsor or its designees contacting you via a live call or text message to your mobile phone if you are a potential winner, which will be subject to the charges pursuant to your wireless service provider's rate plan. On or about each of the Drawing Dates listed above, an independent judging organization will conduct a random drawing to select the potential winner from among the applicable eligible entries as described above. The releases hereunder are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of laws requiring the intent to release future unknown claims.
